**ARTICLES OF INCORPORATION
OF
WOLF PAWS INC.**

Pursuant to the Non-Profit Corporation Law of Tennessee, the undersigned person who is a citizen of the United States, does hereby submit these Articles of Incorporation for the purpose of forming a Non-Profit Corporation.

ARTICLE I

Name

The name of the corporation shall be: Wolf PAWS Inc.

ARTICLE II

Existence

The corporation shall have perpetual existence.

ARTICLE III

Effective Date

The effective date of incorporation shall be: upon filing by the Secretary of State

ARTICLE IV

Members

The corporation will not have members.

ARTICLE V

Type of non-profit corporation

The corporation is not for profit and a Public Benefit Corporation.

ARTICLE X
Indemnification

The corporation does indemnify any directors, officers, employees, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable statute.

ARTICLE XI
Purpose

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The corporation is being formed for the purpose of rescuing abandoned and abused wolf-dogs, providing a permanent sanctuary for them, providing an environment where these animals can be scientifically studied by individuals and institutions to further understand the wolf-dog / human interaction, and educating the public about proper care of pet animals.

The character and essence of the corporation is the same as the purpose.

ARTICLE XII
Prohibited Activities

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article XI. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.


ARTICLE XIII
Distributions Upon Dissolution

Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
